### Are you aware of the injustices occurring in the criminal justice system?

Let me once again address the situation of the parole board - the governor's parole board. They follow his resolution totally or they are replaced. The parole board was set up to allow men and women to be released earlier than their original sentence, and it was the board's purpose to consider institutional behavior, remorse for their crime, and amount of time served. When parole was instituted, the judges were aware of the time the inmates would have to serve before they were eligible for early release, so they sentenced the inmates accordingly. Then parole for new inmates was done away with. Supposedly to be tough on crime, those inmates are now responsible to

serve 85% of their time. The men and women under the old parole law were still eligible for parole, but, as I have said over and over, many of them have now served two or three times the amount of time they were expected to serve when sentenced by the judge. Someone might say this is a good thing. At lease these dangerous people are out of society. However, if these men are not being released, the tax payers are housing men and women who may have truly turned their lives over to God. Tax dollars are being spent unnecessarily and the jail is overcrowded because the DOC does not have bed space. Do we, as a society, really want to set a precedence that when a man

or woman has been rehabilitated it is not enough to allow them to go home? The DOC (Department of Corrections) states its purpose is to rehabilitate or correct. They showed a strong desire to stop the use of the word prison and wanted society to see them in a different light. When people are just being housed with little hope of being rewarded when they change, society has failed in a major way. I think it is time for society to sound off about people being eligible for parole but still being refused proper consideration. Someone needs to be held accountable for that. They are following what the governor has demanded of them. Let's do something about this.

### Another injustice that is already out of hand. Civil Commitment!

I have mentioned before what is called Civil Commitment. This is when a person convicted of a sex crime must be evaluated before he is released after serving his or her entire sentence. If the court thinks, because of statistics, there is a chance this inmate might commit another similar crime, he or she can be held indefinitely. Since society is so affronted by sexual offenders, the DOC and court system seem to think these men and women no longer deserve any rights. Before someone says, "If you had someone sexually offended, you would not be defending these people," I tell you that my niece was indeed attacked by two young men who tried to rape her. I am not opposed to violent offenders being incarcerated indefinitely if it is a known fact they are a danger to society. However, I am not equipped to know the heart of man. I am not comfortable when a man is sentenced to 15 years for a crime, serves that time, and then the DOC sends this man back to court to have a psychologist discern if this man or woman is likely to commit another sexual crime. I do not know if society realizes how serious it is when someone is tried for something a psychologist figures they **might** do some time in the future. This court is then allowed to commit this person to a mental health facility indefinitely. In this process, the person is taken to jail from the prison and must appear in court in a trial where there is a prosecutor and a psychologist who will try to convince a jury it is more likely this person will commit another crime than not. They do this because of statistics accumulated over a period of time. The one on trial has served the time the law determined for the crime and is now being tried for what they **might** do some time in the future. If this jury finds it possible this crime might occur, the person in question is sentenced indefinitely to a mental health facility not a part of the DOC. Each year thereafter these inmates or residents are taken back to court and made to go through this trial all over, with one psychologist on the prosecution's side and one appointed to represent the inmate's side. Plus, each year they will need an attorney. There is not a lot of talk about the cost of this program, but it is certainly not the answer to preventing

#### sexual crimes.

When someone is considered a sexual predator, I can see the need for very serious concern if this person is put back into society. I am not blind just because I do prison ministry. I know what a danger someone is who has a violent nature and continues to commit violent crimes when they are released after their sentence. This is something the judge should take into consideration after someone repeats a violent crime. If someone continues to repeat any crime, they should be made accountable, but I do not think anyone is qualified to foretell the future as to what someone might or might not do. So, the law should be clear concerning the increased penalty for repeat offenders. No one, in spite of the severity of a crime, should be permitted to keep an inmate incarcerated for something statistics say could happen, nor should this law be retroactive to those incarcerated before this civil commitment was made into a law. When the law is not held accountable it easily becomes lawlessness.
