

24 YEARS OF SUCCESSFUL MINISTRY

Twenty four years ago this month Ron was released from Staunton Correctional Center after being paroled on his 13 year sentence. While incarcerated he felt a calling to minister to those incarcerated in the jails and prisons as well as trying to prevent youth from following in the footsteps of an incarcerated parent. Ron was unable to return to Staunton immediately due to security reasons. He was told the risk of illegal activity by an ex-inmate returning as a volunteer outweighed the potential benefit. Ron persisted in trying and later he was told perhaps he might be approved after he completed his parole. Sure enough, after he was released from parole he went in to be approved as a volunteer for a seminar with an already established Prison Fellowship group. He then received letters of recommendation from the then leader of Prison Fellowship and other ministers

who became acquainted with Ron through his ministry in the local jails for the last three years. The person in charge of allowing the group orientation happened to know Ron from when he was incarcerated and was not sure he could be approved as a volunteer. She decided to call the Captain in charge of the day shift and he said, "I remember Baker. Sure you can let him go through the orientation." The Warden of Staunton who had originally denied Ron volunteer status was now a Regional Director and there was a new Warden at Staunton. After the letters of reference were reviewed. even knowing Ron was an exinmate, he was approved not only as a volunteer for the seminar but also for the regular Friday evening PF Bible study. After being approved as a volunteer at Staunton, Ron began to apply at other prisons under the ministry of Rehoboth Jail & Prison Ministry and usually, after being

turned down a few times, he was approved. In the beginning, Ron paid all of the cost for travel, much as other volunteers for PF did. As some churches and individuals became aware of how often Ron was going into the jails and prisons, some of them decided to help with funds. That was when Ron was told he needed a board to help him be accountable, and he did just that. At first, members of Ron's church were the board members; and later, as the ministry grew, a wider variety of board members volunteered. We have been praving for additional board members for about two years or so, and as you can see we have added three new members this year. We hope to add another member shortly. We still need a volunteer CPA to bless the ministry with experience in finances as we progress toward opening the Restoration House Program. Pray for this need!

Rehoboth Jail & Prison Ministry it was a necessity to get our own tax ID number after 23 years of working under Rehoboth Mennonite Church. So, in Sept we began the process of filing our 501-C3 and becoming incorporated. The incorporation took 3 to 4 weeks. However, the 501-C3 took much longer. We had started this process several years back, but without an attorney we found it very difficult to fill out the application completely. We attained an attorney in Sept and he made some valuable suggestions, which we followed, and now the ministry is registered separately as a nonprofit organization, praise God. We certainly appreciate the help of the law firm and the attorney who made this all go much smoother than it was going when we were trying to do it on our own. It is our desire to get a tax attorney who would be interested in assisting us pro-bono until we have the financial backing to afford to pay for these services. It is my understanding the attorney or CPA could write off the work they do for the ministry. Either way, we are continuing to move forward as God allows.

EHOBOTH JAIL & PRISON MINISTRY FORMS A WOOD MINISTRY FOR THE NEEDY

WHAT USED TO BE COULD BE AGAIN.

I remember when men who had served a greater portion of their time could go home for a weekend furlough. I remember when the major institutions had arts and crafts shops where the men could actually use their time to make things to send home and even sell to make some extra money so their families did not have to send them money. I remember when there used to be more industry work where men could make more than a few cents an hour and they could actually help out their family. I

also remember when the inmates were not charged for medical visits. I remember a lot more productive things and better conditions for the inmates in the past than now. I also remember why some of these blessings were taken away. Along with budget cuts, some of the causes for no longer having these benefits were misuse of them. I remember a man actually using his furlough to kill his girl friend. Therefore, no more furloughs for anyone. I remember men going to the medical department for trivial

issues, costing the state large amounts of money. Now that the men have to pay, you do not see that. I was very disappointed when the state did away with arts & crafts because it really helped the men pass the time in a more positive manner. So, if you have something now that is a blessing to you while incarcerated, show the authorities appreciation for it. Also remember, if you mess up it could ruin it and other programs for future inmates. It is not always the DOC's fault when things are taken away.

GARY AND ARTIS OFFICALLY JOIN THE MINISTRY TEAM

As you know by now, these newsletters are done several months ahead of time. We mail them out in order to allow plenty of time for them to be edited without putting pressure on the volunteer editors.
