Pray For Those Who Society Has Forgotten!

There are many criminals in prison who will be there the rest of their lives. They have done terrible things, and their family gave up on them and so has anyone who knew them on the street. Spending many years in prison or facing a life sentence with no chance of parole seems to be sufficient punishment for any crime, still leaving a chance for the inmate to accept Jesus. Christians who were bound for hell before God called them to salvation should not turn their back on the lost who got caught by the law in their sin. Who knows what God can do to a terribly lost soul (like Paul) when they are shown the love of God from a stranger who does this act in writing and encouraging them as commanded by the Lord.

"I was in prison and you visited me," in the way of an encouraging letter sharing the good news of Jesus. I have shared stories of men and women who society gave up on and who after a Christian pen pal and the anointing of the Holy Spirit, turned a life around. That person will still spend the rest of their life in prison, but they share that they are freer now than they have ever been.

I knew a Muslim who was on death row in VA many years ago. He converted to Christianity and prayed while on death row, turning his life over to Jesus still figuring he would die in prison. Then VA abolished the death penalty and commuted those on death row to life. This inmate was now eligible for parole after 15 years. He served many years both on and off of death row. I knew this man personally and experienced his story personally. Eventually he was granted parole, and I saw this born again Christian go home from death row to eternal life.

I knew another man who died this year who was convicted of murdering his wife and sentenced to life. He always insisted he was innocent, however, the court convicted him with DNA evidence found at the scene of the crime. This man served the Lord during his entire incarceration. I served time with him, and we were friends. After I was released, I was able to go into the prison and share the Word with him. He and I served in the Christian Fellowship group as leaders while at Staunton Correctional Center. Back in September 2004, Mark Warner, then Virginia's Governor, ordered a random audit of a number of old criminal cases after a vast trove of biological evidence was discovered lying around in old case files saved by state forensic serologists. When the DNA evidence of this man was checked with the evidence that convicted him, it was found not to be his. He had spent 38 years in prison serving the Lord. This man was married in prison, and he and his wife served the Lord until God took them both home.

Corruption in the Criminal Justice System is Getting Worse

While I understand the need for a death sentence, I have a big problem with the corrupt and perverted criminal justice system and many of the judges who preside over many serious cases. All we have to do is look around at some of the trials going on in our nation today to know this is not something new, it is just more televised. When God sentences one to death, I have absolutely no problem with that, but man is not God, so one has to be careful with how such authority is given to our human judges. We as Christians cannot stand by thinking "these people are criminals, so they are getting what they deserve." In many cases that is true, terrible people are being removed from society so they can no longer bring harm on innocent people. However, there has to be some kind of accountability to those people dealing out what they call justice.

If we look around at some of the trials recently that seem to be political and how we can see the bias so clearly, how can we not imagine that when someone is on trial for what is a terrible crime and society, without any proof of this persons guilt, cry out in public for the harshest sentence putting pressure on a judge to perhaps, not judge on the evidence presented which shows real doubt as to this persons guilt, but instead being swayed by social pressure to convict when the evidence in just not there.

It reminds me of a trial many years ago when the judge persisted in saying he found no reason to find this person guilty over and over, but because of the pressure, this judge still turned this innocent person over to the crowd. Even though this was destined to happen, it does not nullify the guilt of the judge in Jesus' case.

Things are not going to get any better with our government or the criminal justice system, or the prison system if Christians just sit by and do nothing. "The only thing necessary for the triumph of evil is for good men to do nothing." It's a quote routinely attributed to Edmund Burke. Are Christian guilty of this today thinking that is none of my business. If evil and injustice is happening to anyone, no matter who or how unpopular that person might be, it is all of our business.

We are in the last days. If we do not do all we can do to make these last days better, it could be our last chance to do anything to help America and the world to be a little better before the end. I would hate to think I could have prayed more fervently for the things I see that are not in God's will. I would hate to think I could have helped someone lost, who needed Jesus. I would hate to think I judged someone not thinking he or she deserved salvation, especially looking back at my own past.

People prayed for me, and God changed my life. That is how God works. Jesus said: "I have not come to call the righteous, but sinners, to repentance." Luke 5:32 So all of those who think they are so good that they do not need a savior and continue in that frame of mind might just need our prayers for God to show them how their goodness compares to the perfect God we serve.

So maybe we need to broaden our prayers to include things and people outside our regular prayer routine. Let's start today!

Prison Ministry Diminishing in Importance Over the Years Because of the DOC Policies

Years ago in the 70s and 80s, I remember having a Bible study from outside church volunteers bringing the Word of God to us. Speaking of just true Christians groups, not counting the cults, we had a service every evening. We had a church service Sunday morning, and we even had a church service on Sunday evening. All of these were from various church groups. These services seemed to be encouraged by many of those in authority. Not anymore!

Since the pandemic and the constant lockdowns, whether there was a lot of COVID cases or not, most programs were being canceled— even family visitation.

However, even before the pandemic when we were going into Buckingham and Dillwyn prisons, the VA DOC made a decision to make the men chose to either attend a Bible study once a week or a church service. Before the men were having Bible studies several week nights and attending church on Sundays. Now they must choose between church or Bible study. Of course this affected volunteers also. Even though I was able to keep an evening service at each prison, with the men having to make a choice, many chose Sunday worship and the number of men attending Bible study went from over 60 to 8 at Buckingham and 4 at Dillwyn. Many volunteers lost the spot completely after years of service to the DOC. They just cut them out of the work the Lord had called them to do. We worked hard to keep our nights

Soon after, the VA DOC changed the church services on Sunday with some being held on Thursday evenings or during the week, and it was called the Protestant services. Each Bible study group had to specify a denomination for their group, such as Baptist, Methodist, and so on. Since I had always gone in as nondenominational, just teaching Jesus Christ and Him crucified, I was in a dilemma. The institution named my night the Mennonite service. I explained that many inmates would not know what the Mennonites taught and that I was teaching the Bible. I had to end up taking that name, since I could not call it nondenominational, and the other names were already chosen. This decreased all of the

evening Bible study attendance, not only mine.

Through the years I saw an increased lack of interest in religious services from the administration as well as other programs. I remember driving 60 miles in bad weather just to be told there was no program that night. I would call before I left home, but the day shift was still on duty, and even if they said as far as they were concerned services were a go, when the night shift came on they might say, "No service." After complaining enough about that, the program coordinator was supposed to call the volunteers if there was a lockdown, but we still had the same problem since she would actually be gone when the night shift came on. Now the staff or someone in charge can shut down all movement for weeks or months because one person tests positive for COVID. At first, they were checking the officers every couple days and testing all volunteers every time they came in. Later they stopped testing the staff unless they said they felt ill. Some of the inmates who wrote me told me their cell area would be COVID free

only to have the institution move an infected positive case into their dorm. I know that is hard to believe, but I have heard it enough and from men I trust that I fully believe it. I believe it is cruel and unusual punishment to give the men a week of freedom and then take it away for a month or more. They are not being allowed to go to the commissary to get writing supplies or hygiene items for long periods of time. One of the worst situations that came about was with family visitation being denied for long periods of time. When the family is allowed to visit, the wife was not allowed to hug her spouse and the inmate was not allowed to hug his children. That has finally changed. How do you explain to your little child, "Daddy is not allowed to hug you?" I fully understand the precautions being taken; however, if the family is tested and comes up negative, why not allow a hug when the staff was not even being tested anymore? There are many truly born-again Christians in prisons. Should they be forgotten because they made a mistake? I say God forbid!

What can you say that you did to further the kingdom of God when you see Jesus face to face? Who did you share the gospel with in order to see them drawn to Jesus? You might say I am not a preacher, what can I do? You might say I am home bound, and I am not able to travel to foreign countries as a missionary. What would you say if I told you that you could be a missionary without leaving your house? Sitting at your table or desk or at your computer you can make the life of someone incarcerated brighter by sharing God's Word and His love through a letter. This only takes a short time. You do not have to leave home to do it. Although snail mail or letters might not be as popular today; when you are away from home and never hear you name called at mail call, it is one of the brightest spots in your day. Think of those Jesus reached out to. ³² "I have not come to call the righteous, but sinners, to repentance." Luke 5:32 If these people do not hear about God from some place, how will they ever be saved? ¹⁴ "How then shall they call on Him in whom they have not believed? And how shall they believe in Him of whom they have not heard? And how shall they have not heard? ¹⁵

And how shall they preach unless they are sent? As it is written: Romans 10:14-15 These people have to hear about God when He might be the last person on their mind. Jesus shares "Assuredly, I say to you, inasmuch as you did it to one of the least of these My brethren, you did it to Me." Matthew 25:40

This is the update for Rehoboth Jail & Prison Ministry and Bible Readers Outreach Ministry for the months of Non/Dec 2024

Bible Readers Outreach Ministries:

In June 2024 we mailed out 242 Bible lessons, enrolled 28 new students, mailed 7 Bibles at \$161.68 for starting Old Testament, 5 Bible dictionaries/concordances at \$102.61. Old testament Vernon Magee concordances 2 @ \$62.17 Misc. office materials (paper, envelopes, ink, cardstock) \$200.00, Stamps \$988.25 for a total of \$1514.71 (The stocked up on stamps before the raise the price.) In July 2024 we mailed out 258 Bible lessons enrolled 21 new students, mailed 9 Bibles cost of \$263.86, 5 Bible dictionar-ies/Concordances at \$79.66 Old testament Vernon Magee concordances O Misc. office materials (paper, envelopes, ink, cardstock) \$0 Stamps \$1465.34 for a total of \$ 1808.86.

Rehoboth Jail & Prison Ministry Pen Pal Outreach:

In June. 2024 I wrote 59 letter and received 12 new request during that month for volunteer pen pal. New volunteers to write inmates. None

In July 2024 I wrote 80 letter and received 15 new request during that month for volunteer pen pal. New volunteers to write inmates. None

I also received 1 letter written in Spanish which I could not read. I have no Hispanic volunteers to respond to these request. I have the letter translater and I use Google translator to change my English to Spanish to write back. I need a couple Hispanic volunteers

Please keep both divisions of this ministry in your prayers. Since I send the letter to be edited and give the editors time to edit I go back a few months so we can get an accurate count and not have to wait until the last day to add the month before the newsletter goes out.
